### Notes:

3. The above rates are inclusive of accommodation, electricity and water costs for up to a maximum of eight persons.

## 2. Terms and Conditions

1. Arrival should be after 4.00 p.m. Florida time unless otherwise agreed. Property must be vacated before 11.00 a.m. on the day of departure.

2. Cancellation charges will be applied as follows:

Over 90 days notice    Deposit refunded in full

30 - 60 days notice    50% of total rental

Less than 30 days    100% of total rental

3. The owners or their agents will not be responsible for any loss or delay caused by force majeure, including the following: Strike, hostilities, war, terrorist activity, riots, fire, flood, inclement weather or any travel problems associated with airlines or other means of transport.

4. A security bond of \$150 will be held by Behlor Realty Inc, to insure against loss or damage occasioned by the use of the property by the parties to this agreement and is acknowledged by the signing of this agreement. The security bond will be refunded fully after a satisfactory status report has been received by the management company.

5. If changes to the booking are requested, every effort will be made to accommodate them. This may require additional charges to be made.

6. Guests are reminded that owners, owners agents and all management companies associated with this agreement do not take any responsibility or liability for injuries, however caused, when using swimming and other sporting facilities offered as part of this agreement. In particular, **children should be supervised at all times when using swimming pools.**

7. The total rental **MUST** be received by **Doral Woods Management Inc.** 4 weeks before the start of the rental period.
